2. Rules that were voted on at this meeting and the results;

Rule 7.B.1. Both bars buy a round of 10 drinks (home and visitor)

Rule was changed by a vote of 6 to 0 to the following;

B. Home team buys 1 round and visitors buy nothing and sponsor fee goes up to 100 from 50 due to the fact that the bars would save 30 per week by not buying that extra round of drinks.

Rule 7.A.1 and A.2 League divided into two divisions etc etc

Proposed to change to;

League will remain as one division and not be divided into two divisions.

Rule will stay the same as it was voted down 8 to 0. League will remain as 2 divisions

Rule of 5 man teams and 15 games per night,

Proposed to change to;
