Per league Rule 1.B.1 All tables will be inspected halfway thru the season. We will be doing this over the Thanksgiving Holiday so please make sure your table complies with all league rules. This may include, but is not limited to, lines drawn designating the kitchen, bridge, chalk/powder, lighting, loose rails, felt in playing condition, level table, etc. Please see page 2 of your rules packet for specifics. Also, refer to Rule I.B.9. All infractions, will incur a \$5 fine if not rectified within two weeks of notification from officers. This will be deducted from the team's prize money.

League Dues

Numerous shooters have not paid their second half league fees, due on the 13th week, which is December 9th, this coming Monday!! There is no reason to be late with these!

ROSTERS / SUBS

CAPTAINS, CHECK THE STANDINGS SHEET! If a shooter that was supposedly on your roster is not listed on the current standings sheet, THEN I DON'T HAVE HIM ON YOUR ROSTER!! You need to contact me asap,,,,DO NOT WAIT UNTIL MONDAY TO TRY AND ADD SOMEONE! I have said for the past four or five weeks, (actually almost every week since week one), to double check that all of your subs are listed and that they are spelled correctly. Do not assume that because you told me, or sent a text, or what have you, that it got put on there. If you need to add someone, it must be done the week prior so that the player is actually listed on the standings sheet before he subs. See page 3 of the rule book under Rule 1.D.4. Also, you can always upgrade players back to a "sub" status from "inactive", but you also need to do that a week ahead of time as well.
